Eligibility of Members

A, Must be above 18 years of age.

B, Must be a spouse, Father, Mother or child of UN staff with proof of kinship.

C Must be of sound mind.

D, Must be in active employment/having steady source of income

Minimum requirements (registration)

1. Pay 10,000 ugx registration fees and 5000/= for membership card
2. Buy 100 shares of 10,000 ugx each.
3. Opening Savings Deposit of 500,000 ugx

Access to loan products

4. Savings for 6 months

2. UNS-SACCO Family –Silver Savings Account (FSSA)

Eligibility of Members

A, Must be above 18 years of age.

B, Must be a spouse, Father, Mother or child of UN staff with proof of kinship.

C Must be of sound mind.

Minimum requirements (registration)

1. Pay 10,000 ugx registration fees and 5000/= for member ship card.

2. Buy 50 shares of 10,000 ugx each.

3. Opening Savings Deposit of 300,000 ugx

Access to loan products

1. Savings for 6 months to access loan products.

2. Must have gained active employment as par assessment for the loan.

3. Subject to Loan levels and determined by the credit committee.

3. UNS-SACCO Family- Watoto Savings Account (FWSA)

Eligibility

1. Must be below 18 years of age.

2. Must be a child to UN staff with proof of kinship.

Minimum requirements (registration)

1. Must have a trustee who must be UN Staff.

2. Joint account to be opened.

3. Pay 10,000/= registration fees and 5000/= for membership card.

4. Buy 30 shares of 10,000/= each.

5. Opening Savings deposit of 200,000/=

NOTE: For (FWSA) ONE CAN ONLY ACCESS LOAN PRODUCTS AFTER ATTAINING MAJORITY AGE AND TRUST BENEFICIALY RELATION SHIP CEASE TO EXIST AT THIS POINT.
